

Rules/Regulation/Restrictions and or limitations

FLOAT RIDERS

- The name of the designated "Float Rider" must be submitted to the Odd Fellow-Rebekah Rose Float Organization prior to October 31, 201_. Additional information required by the TOR must be supplied. Deadlines for programs will influence the 10/31 deadline.
- The Rider must sign and agree to the Tournament of Roses' (TOR) liability forms and requirements.
- Riders must comply with all rules and regulation of the Tournament of Roses organization and the Phoenix Decorating Company.
- The Riders must sign release of liability, releasing the Odd Fellow-Rebekah Rose Float organization from any injury, loss or liability.
- It is suggested that the Riders participate with the decorating of the float.
- Riders must be present during float judging on December 31, 201_.
- Riders must arrive ready to be placed on the designated float 2 hours prior to start of the parade on January 1, 201_.
- Rider costume's must be supplied by sponsor and conform to all TOR regulations.
 They must conform with the theme of the Float and approved by the Float Committee.

General Guidelines

- · Sponsorship payment is due and payable upon signature of agreement.
- · Payment options must be addressed and approved prior to signing the agreement.
- · The Odd Fellow-Rebekah Rose Float organization (OFRRF) will not be liable for any accidents, mishaps, losses and or lawsuits.
- \cdot Sponsorship advertisement in official promotional materiel must be submitted prior to Tournament of Roses press releases completion date.
- · All Sponsorship logos on apparel must be approved and conform to the theme of the float.
- · Authorized and approved "Sponsorship Banners" placed at the decorating site must receive prior written approval from the Odd Fellow-Rebekah Rose Float organization.
- · Advertising by the sponsor (or its representative organization) is encouraged but must be approved by the Odd Fellow-Rebekah Rose Float organization.
- · Sponsors shall conform to all rules and regulations of the Tournament of Roses foundation.
- · Sponsors agree to abide by the discussion of the Odd Fellow-Rebekah Rose Float organization in the event of any misunderstanding, regulation and or restriction.
- · Sponsors wanting to assist with the Decorating of the Float must coordinate requested work schedule with the Odd Fellow-Rebekah Rose Float Crew Chief and conform to the Rules of Phoenix Decorating Company.
